By accepting this Application by the Bank, it shall be deemed that an agreement on the use of RBA iDIREKT SERVICES has been made between the business entity and the Bank, and the Bank shall charge the fee for the use of the service by directly debiting the account.

All users - applicants for the use of RBA iDIREKT SERVICE state that they agree that all personal data which the Bank acquires under positive regulations, i.e. all data that the authorized persons have made available to the Bank at the occasion of arranging the RBA iDIREKT SERVICE, and all data which the Bank should learn while executing the Agreement on the use of RBA iDIREKT SERVICE may be further processed, used and published for the purposes of processing or provided for use to the members of Raiffeisen group in the country and abroad, for the purpose of risk management, creating a joint database of clients of the afore mentioned group, delivering informative offers on services provided by the members of the group, the possible assignment of claims which the Bank has in respect to the Client, in the aim of preventing money laundering and terrorism financing, and in the aim of handling complaints. All users - applicants for the use of RBA iDIREKT SERVICE state that they agree that all data on the Agreement on the use of RBA iDIREKT SERVICE may be communicated to FINA for the purpose of issuing the Certificate.

AGREEMENT on providing certification services

Article 1.

The rights and obligations of the contracting parties as under this Agreement are derived from the provisions of the Regulation (EU) No. 910/2014 of the European Parliament and Council of 23 June 2014 on electronic identification and trust services for electronic transactions in the internal market and repealing Directive 1999/93/EC (hereinafter: eIDAS Regulation), Act on implementation of the Regulation (EU) No. 910/2014 of the European Parliament and Council of 23 June 2014 on electronic identification and trust services for electronic transactions in the internal market and repealing Directive 1999/93/EC, Certificate Policy for Qualified Certificates for Electronic Signatures and Seals or Certificate Policy for Non-qualified Certificates (hereinafter: CPQC-eIDAS, or CPNQC-eIDAS), Certification Practice Statement for Qualified Certificates for Electronic Signatures and Seals or Certification Practice Statement for Non-Qualified Certificates (hereinafter: CPSQC-eIDAS, or CPNQC-eIDAS), Terms and Conditions of Providing Certification Services for Personal Certificates (hereinafter: Terms and Conditions) and other acts of FINA on providing certification services.

FINA undertakes to make the acts from paragraph 1 of this Article and the price list for certification services available on the internet address <http://www.fina.hr/finadigicert>.

Article 2.

Upon receiving a written request from the Business Entity and following the completion of the required procedure, FINA shall perform the following services (using the appropriate forms in paper or electronic format):

- 1) issuance of certificates for the signatory
- 2) revocation, suspension, reactivation and recovery of the certificate

Article 3.

In consideration of the services specified in Article 2 of this Agreement, the Business Entity shall pay a fee to Raiffeisenbank Austria d.d. (hereinafter refer to as the Bank) as a party which performs registration activities on behalf of FINA. The fee payment method is defined in a special agreement made between the Bank and the business entity.

If the contractual relationship between FINA and the Signatory continues even after the business co-operation between the Bank and FINA has ceased, the Signatory shall pay the fee to FINA, in keeping with the price list for FINA services, within 15 days from the invoice date, save if otherwise defined by other acts. The Bank will notify the Signatory on the termination of the relationship between FINA and the Bank.

Article 4.

This Agreement comes into effect as of the date of being signed by the person authorized to represent the business entity, if the Agreement on Use of RBA iDIREKT SERVICE between the Bank and the Business Entity has entered into force. In case the Agreement on Use of RBA iDIREKT SERVICE should enter into force after the date of signing this Agreement, this Agreement shall take effect as of the date of the Agreement on Use of RBA iDIREKT SERVICE. In respect of each signatory, this Agreement shall take effect as of the date on which the respective signatory signs the receipt of RBA iDIREKT package with the advanced electronic signature tool, provided the Agreement on Use of RBA iDIREKT SERVICE between the Bank and the business entity has become effective.

Article 5.

The Agreement is entered into for an indefinite of time. The Business entity may terminate the Agreement in writing, without stating its reasons. FINA shall terminate the Agreement if:

- 1) the Business Entity or Signatory fails to meet any requirements provided in CP or the Terms and Conditions,
- 2) the Business entity or Signatory acts in violation of any provisions of this Agreement,
- 3) FINA may terminate this agreement and revoke the certificate in case the business entity ceases to be a client of the Bank or receives the Bank's notice that the account of the business entity has been blocked, unless the contractual parties agree otherwise

In case of cancellation or termination of the Agreement all certificates issued hereunder shall be revoked. If this Agreement is cancelled by one or several signatories or the business entity cancels it for one or several signatories, or FINA cancels it for one or several signatories, it shall cease to be valid only for the said signatory/signatories, and remain in force for other signatories. In that case all certificates issued to the respective signatory/signatories shall be revoked.

Article 6.

The parties shall use their best efforts to resolve any disputes between them amicably; failing this, they shall submit to the jurisdiction of a competent court in Zagreb, Croatia, in accordance with the provisions of Croatian law.

Article 7.

This Agreement is executed in two counterparts, one for each party to the Agreement.
