^{**} The FATCA (Foreign Account Tax Compliance Act) is an Act on the fulfillment of tax obligations with respect to the accounts held in foreign Financial institutions. The FATCA status shall be given to any person for whom it is determined to have any of the indicators due to which this respective person is subject to the US Foreign Account Tax Compliance Act, directed at preventing the US tax payers to avoid paying taxes by holding foreign accounts. Implementation of the international agreement is regulated by Act on administrative cooperation in tax matters (OJ 115/2016).
