



DATA ON THE BENEFICIAL / ACTUAL OWNERS OF THE CLIENT

In accordance with the article 8 and articles 23 and 24 of the Croatian Act on Money Laundering and Terrorism Financing Prevention (National Gazette 87/2008) the Bank is obliged to obtain data on the beneficial/actual owners of its clients, legal persons.

Actual / beneficial owners of legal persons (their branch offices, representative offices), and other companies under domestic and foreign law that are considered equal to the legal entity, are:

- A. any natural person who, directly or indirectly owns a sufficient percentage of stocks, shares or voting rights in the legal person. A sufficient percentage of stocks, shares or voting rights is at least: 25% + one stock; more than 25% shares; more than 25% voting rights
- B. any natural person who, in some other way exerts influence over the legal person's Management board and who controls the process of making financial and business decisions Actual / beneficial owners of other legal persons, such as foundations, fiduciary business which manage and distribute cash assets, are considered to be:
- C. any natural person who owns more than 25% of property rights in a certain legal business – if the future owners have already been designated
- D. person or a group of persons who have an interest in the legal business, i.e. in whose interest the legal person was founded or in whose interest it conducts business – if the natural persons or legal persons who will benefit from the legal business have still not been identified
- E. any natural person who, directly or indirectly, controls over 25 % of property rights of a certain legal business.

DIRECT/INDIRECT OWNER - direct owner is any natural person which directly participates in the ownership structure of a business entity for which data is obtained. Indirect owner is any natural or legal person, owner of another legal person which participates in the ownership structure of a business entity for which data is obtained.
